

Conditions



1. General

The following general terms and conditions apply to every contract, dispatch and other services of belgischerbrocken.com (Steffen J. Lindner).

2. Offer

All offers and prices are subject to change without notice, unless they are confirmed in written offers.

All orders are subject to rejection, unless they are confirmed in written words or are confirmed by delivery with invoice.

By placing orders on this site the customer is attesting to the following:

- a. There are no federal, state or local laws prohibiting you from purchasing the items ordered.
- b. You are of legal age or have parents permission to order these items.
- c. You are the owner of or have permission to use payment instruments.
- d. You accept the General Terms and Conditions of belgischerbrocken.com (Steffen J. Lindner).

3. Delivery and settlement

Belgian Sharpening stone distribution (Steffen J. Lindner) will make any effort to have any order shipped and delivered the fastest way possible.

Shipping will be done on cost and danger of the customer, unless another method is chosen by the customer or is clearly indicated by belgischerbrocken.com (Steffen J. Lindner). The method of shipping and the carrier will be chosen by belgischerbrocken.com (Steffen J. Lindner), after confirmation of shipping cost has been reached both by the customer and belgischerbrocken.com (Steffen J. Lindner).

The information about delivery cost are fixed in detail on this site (click on DELIVERY).

No minimum order is required, our prices do not include any value added tax. German customers are invoiced with additional 19 % VAT.

4. Delivery time

All items that are offered in this webshop, are usually on stock. All orders will be forwarded within three working days unless otherwise stated.

Once the goods have been handed over to the delivery firm, we have fulfilled our contractual obligations and all risk shall pass to the buyer.

If it is not possible to deliver the ordered items (or equivalents in terms of quality and price) in time, we shall be authorised to terminate the contract and refuse delivery. In such an event, we undertake to inform the buyer immediately that the goods can not be delivered in time and to refund any payment of the buyer.

5. Return of goods

Every item that was purchased at belgischerbrocken.com and is still in original packing and unused, can be returned within 14 days after delivery, your transferred money (ex shipping cost) will be refunded immediately.

We will also refund the postage, if we are liable for sending you a wrong order or if your order is damaged for any reasons. Please never send back to us anything without postage, we will not accept such shipments and reject..

No reasons have to be mentioned, why you returned your order. But we would like to have satisfied customers, and would kindly ask you to enclose your reasons to the returned postage, thank you !

6. Guarantee

a. If the item to be delivered is defective, including the absence of warranted characteristics, we shall be authorised, at our own discretion, to repair the defective item or to deliver a new item. If the repairs or new delivery prove ineffective, the buyer shall be entitled to a discount on the price or to rescind the contract.

b. The buyer is required to allow us to inspect the defective item.

c. The provisions of paragraph a and b above shall apply accordingly to any claims by the buyer arising as a result of recommendations or advice of the breaching of obligations to inform, notify or advise the buyer within the framework of this contract. If the buyer is entitled to receive damages in cash, such entitlement shall not be affected thereby.

7. Data storage
